Katie A. Services

Those identified as Katie A. eligible subclass members are provided services in collaboration with Child Welfare, Behavioral Health, community service providers, and tribal partners working with the child/youth and family. This family-centered approach is intended to improve coordination and collaboration among mental health, child welfare, and children, youth, and families involved with the child welfare system who have mental health needs.

Family Service Partnership (FSP)

Children/youth identified as a full services partner, through the Mental Health Services Act (MHSA), are eligible for enhanced services. CSOC FSP is a strengths-based approach to assist children and their families to create positive change and reach their goals.



Family Parent Peer (FPP)

Our FPP offers support, encouragement, assistance, and their experience to help families become even more successful in their goals and achieve long-term recovery. They also offer practical assistance and connections to resources, system navigation, opportunities, communities of support. Through trained skills and lived experience, our FPP assists the family on a journey to improved health, recovery and resiliency.

Early and Periodic Screening, Diagnostic, and Treatment (EPSDT)

Children and youth under age 21 who have full scope Medi-Cal are eligible for EPSDT services, including individual, group and family therapy, crisis counseling, case management, rehabilitation services/life skills training, Intensive Care Coordination (ICC), Intensive Home-Based Services (IHBS), Therapeutic Behavioral Services (TBS), and psychiatric services.

Children's System of Care

Provides services to children with emotional severe and behavioral issues. Services include: evaluation: individual, and family services; case management, rehabilitation, skills training; full service partnership through the Mental Health Services Act; crisis services, and coordination for psychiatric and medication services. Staff members work collaboratively with schools and agencies throughout Siskiyou County to promote family unity and strengthen access to community support systems.

Who we serve

Children, youth, and young adults ages 0-21 who are experiencing symptoms related to mental health, including experiencing trauma, homelessness, challenging behaviors, difficulty maintaining their current placement, are being placed in or discharged from a Short-Term Residential Therapeutic Program (STRTP), or have had a psychiatric hospitalization within the past 24 months.



Access to Services

Access to services for youth begins with a referral initiated by family or other supporting agencies. An assessment is then scheduled and will determine appropriate services or referrals.



Intensive Care Coordination (ICC) & Intensive Home Based Services (IHBS)

For children/youth who qualify, ICC and IHBS are also available. The ICC team will support the child/youth and family with regularly scheduled Child and Family Team (CFT) meetings. IHBS services consist of skills development that is provided in the home or community to support the child/youth and their family.
