Members of the Siskiyou County Behavioral Health Services Board met on this 18th day of February in person. Board Member Ogren called the meeting to order at 3:31 p.m.

Minute Approval: Paul Contreras made the motion to approve Minutes for January 21, 2025, Lise Rogers seconded, motion passed 5-0.

Public Hearing: Annual Update to the MHSA 23 – 26 3 Year Plan

Public Hearing opened at 3:34 pm. All Members were presented with a copy of the Annual Update and additional copies were available to the public. Dr. Collard reviewed the updates from fiscal year 23-24 and discussed the future of MHSA and how the program is changing with the transition to BHSA. Lise Rogers would like the graphs in the plan to be in clearer colors, MHSA Coordinator will complete the change. There were no public comments. Lise Rogers motioned to approve the Annual Update for consideration by the Siskiyou County Board of Supervisors, Earl Chancellor seconded. Motion passed 5-0. Public Hearing was closed at 4:02 p.m.

Department Update: Much of Dr. Collard's update was discussed during the Public Hearing including increase in housing allocations and the loss of PEI funding, which will transition to Public Health. We are down several Substance Use Disorder Counselors and it is effecting a state mandated guideline that clients receive SUD services within 10 days of initial meeting. We have notified the State and Partnership Health Plan and they are working with BH to resolve this issue.

Introduction of Loraine Wisler, AOD Administrator: Loraine Wisler introduced herself and will keep the Board up to date on the status of the department during the leadership change.

ASOC Review: Presenter Kim Romero was unable to attend. This item will be tabled until March.

Goals: Previous year's goals were provided and will be discussed at the March meeting.

Location: Lise Rogers would like to have a Board meeting at the Mt. Shasta location. The date(s) will be discussed in a future meeting.
