Minute Approval: Earl Chancellor made the motion to approve Minutes for January 20, 2025, Donny Forsyth seconded, motion passed 4-0.

30 Day Review and Public Hearing - Approval of the MHSA Annual Update for FY 25/26:

Dr. Collard provided an overview of the Annual Update. No members of the public were present and no questions asked. Earl Chancellor motioned to approve the plan, Donny Forsyth seconded, motion passed 4-0.

Department Update:

Dr. Collard informed the Board that the MHSA team is currently developing the new BHSA Integrated Plan, which will take effect July 1 of this year and replace both the MHSA Three-Year Plan and Annual Updates. The Integrated Plan will combine Mental Health and Substance Use Disorder services into a unified planning framework. Due to increased state data reporting requirements under BHSA, several new administrative positions have been established. Staffing challenges persist within the Substance Use Disorder (SUD) department, and recruitment efforts for vacant positions are ongoing.

Data Notebook: Dr. Collard gave a brief review of the current Data Notebook and provided copies to the Board

Siskiyou County Public Health Presentation: SCPH presented on their new children's oral health services, the Healthy Aging program, the process of becoming an accredited with the Public Health Accreditation Board and current jail services.

Resignation of Board Member: Lise Rogers gave her formal notice to resign.
