Members of the Siskiyou County Behavioral Health Advisory Board met on this 16th day of March in person. Chairperson Ogren called the meeting to order at 3:30 p.m.

Change of Agenda: Chairperson Ogren requested Item 8: Election of Officers, be moved to Item 2. Dr. Collard requested Item 12: BHSA Three-Year Plan be included in Item 7: Department Report. Forsyth made motion, seconded by Hadaller, motion passed 6-0.

Election of Officers: Sasha Hight was recommended for BHAB Chairperson, Justin Hadaller will remain Vice Chairperson.

Minute Approval: Contreras made the motion to approve Minutes for February 17, 2026, Donny Forsyth seconded, motion passed 6-0.

Department Update:

Dr. Collard informed the Board that after 1.5 years of work, we have completed the draft version of the new BHSA Three-Year Plan, which will go to the State to review, then out for Public Comment and Hearing at the BOS. Behavioral Health was awarded the BHCIP 2 grant to fund a new Behavioral Health building in the county owned lot next to the current rented building. Acceptance of grant will be going to the BOS for approval. Annual Audits have started, results will be forwarded to BHAB once received.

Resolution to address BOS re: Mental Health Awareness Month (May)

Draft version was presented to Board, no changes. Forsyth motioned to approve the Proclamation, Contreras seconded, motion passed 6-0.

HomeMore Project: Zac Clark from HomeMore Project attended the meeting remotely and gave a presentation on a transitional housing project that his company is building in Yreka.

PSAII: Teri Gabriel and Cheryl Rushton gave an in-person presentation on programs available through Planning & Service Area 2, Area Agency on Aging.

Board Nomination: An application for the Board was submitted by Shaun Williamson. Short introduction and discussion on qualifications.

Future Agenda Items: Request for tour of Six Stones, Basecamp and Siskiyou Village during April meeting.

Closed Session – Discussion of Board Member Nomination: Board approved nomination of Shaun Williamson to the Behavioral Health Advisory Board.
