The City of Yreka received an application from Darrin Collins to divide Assessor's Parcel Number 053-662-730 into two new parcels. The current parcel contains a single-family residence and a shop. The proposed tentative parcel map would subdivide one 1.17 acre parcel into two separate parcels; the resulting parcels would be approximately 0.60 acres each and the shop would be turned into a single-family residence on Parcel 1. There are no proposed changes to the General Plan Designation of Low Density Residential or the Low Density Residential (R-1) Zoning designation.
