Project Title: City of Dunsmuir Municipal-Mott Airport Fire Fuel and Hazard Reduction Project	
Project Location: The proposed project is located within the City of Dunsmuir at the Dunsmuir Municipal-Mott Airport. Improvements would occur on ~10 acres in the northern area of the airport, east of Mott Airport Road and north of the airport runway (Siskiyou County Assessor's Parcel Number 059-351-020). The property is owned by the City of Dunsmuir. See Figures 1 and 2 .	
City: Dunsmuir	County: Siskiyou
Project Description: The purpose of the project is to reduce fire hazards and comply with Federal Aviation Administration (FAA) requirements to maintain clearance in the airport's flight path. The project includes removal of trees and other vegetation within the ~10-acre area shown in Figure 2 . Cleared vegetation would be removed from the site, and no burning of the vegetation would occur on-site. It is estimated that the work would occur over a period of 30 days.

Reason Why Project Is Exempt: Class 1 authorizes maintenance or minor alteration of existing public facilities involving negligible or no expansion of use, including maintenance of existing landscaping and native growth. The project is consistent with this categorical exemption noted above because the proposed maintenance includes removing native vegetation in a previously cleared area. The project would not have a significant effect on the environment due to unusual circumstances; would not result in damage to scenic resources within a Scenic Highway; is not located on a hazardous waste site pursuant to §65962.5 of the Government Code; would not cause a substantial adverse change in the significance of a historical resource; and would not result in cumulative impacts.

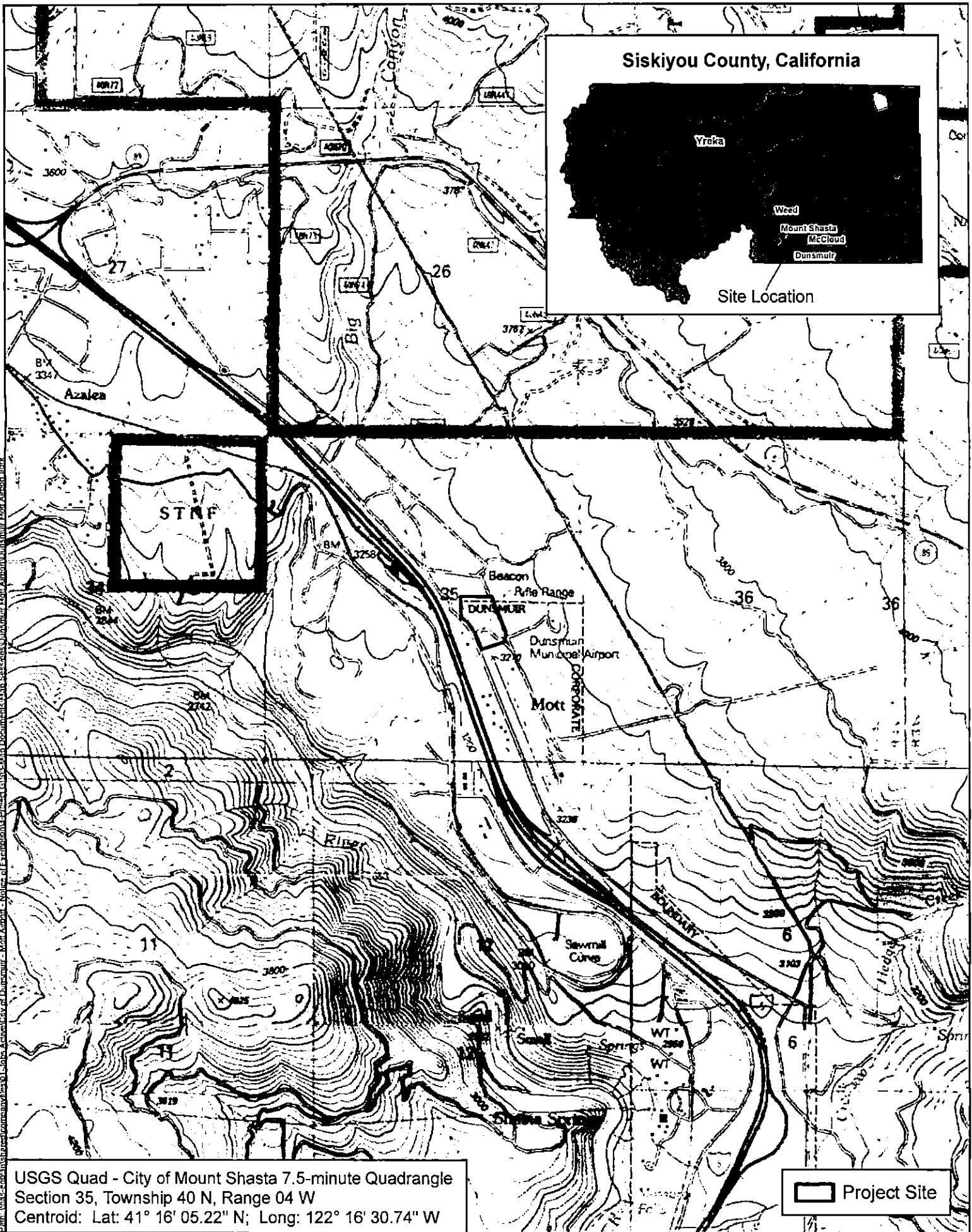
