The proposed drought relief project includes the rehabilitation of two existing wells, replacement of 500 feet of aged cast iron leaky water main, replacement of five service connections, reconnection of two existing fire hydrants, installation of an emergency potable water re-filling station with a drinking fountain, and emergency use water bottle provisions.
