Description of Nature, Purpose, and Beneficiaries of Project:

This project has two goals related to improving wildfire resilience to private property within the Siskiyou Resource Conservation District. The first goal is to treat twenty parcels to create defensible space. SRCD will solicit applicants from the community and select 20 parcels with priority being given to elderly and/or low-income residents living in high or very high CalFire Severity Zones. The second goal of the project is to host two community chipping events to assist residents with reducing woody fuels on private property. Residents will be able to sign up for one of the community chipping days, and SRCD will go to their residence and chip appropriately staged and prepped material and spread the chips on the residence.

This project will benefit segments of the population living in high or very high fire hazard severity zones by creating defensible space around residences and reducing the volume of woody material and ladder fuels. These goals are in line with priorities in the Siskiyou County Wildfire Protection Plan, and all defensible space work will be conducted to CalFire specifications.

Reasons Project is Exempt:

Reasons Project is Exempt: This project will only cause minor alterations to property within the defensible space zone to reduce risk from fire. Alterations will be limited to removal of brush and small diameter fuels and chipping/spreading of material. No scenic or healthy trees will be removed and, there will be no impact on wildlife habitat or riparian areas. There will be no significant adverse impacts to soil, hydrology, or archeological resource sites.
