In the event any licensed agent or broker ("Broker") is found to be a procuring cause of the accepted successful bid, and the successful bidder meets all of the terms of the sale and consummated the purchase as provided herein; then, in that event, the procuring Broker shall then be entitled to receive a commission amounting to one and one-half percent (1.5%) of the successful bid amount.
