Prevent mishandling of chemicals by labeling all spray bottles with a common name. Corrected onsite.</p> <p>13) Observed 200ppm chlorine sanitizer at cook line sani-bucket. Maintain chlorine sanitizer of 100ppm. Utilize test strips frequently or as needed. Corrected onsite.</p> <p>14) Observed food accumulating on the door gaskets to deli prep cooler at the cooks area. Maintain equipment in a cleanly manner at all times and fully serviceable. Correct immediately.</p> <p>14) Observed black slime accumulating in the floor sink basin where the warewashing is plumbed to. Maintain equipment in a cleanly manner at all times as to not attract or harbor insects or develop objectionable odor. Wash, clean, and sanitize immediately.</p> <p>14) Observed raw wood palette used to level a box freezer stored next to reach-in refrigerators in warewashing area. Observed an unfinished wood cabinet used as a table for the espresso machine. Ensure raw wood exposed to splash or spillage is finished as to be smooth, nonabsorbent, durable, and easily cleanable. Repair or correct within 30 days.</p> <p>30) 2nd Notice - Observed paint chipping off wall below warewashing sink. Maintain walls as to be smooth, durable, nonabsorbent, and easily cleanable.
