The following observations were found: 13) 4TH NOTICE- Observed excessive accumulation of food, grease, dust, and/or dirt in all refrigerators, dry storage, and walk-in refrigerator (currently used as additional dry storage). Maintain all parts of the facility in a cleanly manner at all times. Wash, clean and sanitize immediately. A reinspection fee assessed for non-compliance. 20) 8TH NOTICE - Facility has not obtained a Food Safety Manager Certificate. The food manager certificate has expired in 02/2022. Per CRFC 113947.6, a facility that operates without a food manager certificate is punishable by a fine of \$100 each day of operation in violation. This violation was noted in multiple inspection reports in 2022, 2023, 2024, and 2025 with 30 to 60 days to correct. <u>Obtain food manager certificate within 7 days.</u> A reinspection fee assessed for non-compliance. 24) 4TH NOTICE- Continued to observe used grease runoff and buildup on all sides of grease container and onto the parking lot floor. Observed excessive amount of food waste on the top grate causing lid to not close completely. Ensure refuse is cleaned at a frequency necessary to prevent buildup of soil and grease waste are disposed in a sanitary manner as to not attract insects, vermin, and or rodents or cause objectionable odor. Deep clean and wash immediately. A reinspection fee assessed for non-compliance. A reinspection fee is assessed for non-compliance and repeat violations. Future non-compliance will result in additional reinspection fees, administrative hearing, and potential permit revocation. A REINSPECTION WILL BE CONDUCTED WITHIN 7 DAYS. NOTE: Facility has not paid for 2025 Food Permit. To avoid further accrual of late fees, ensure permit is brought into compliance as soon as possible. Continue to work on non-compliance noted on 06/30/2025 inspection report.
