General Services - Approve Memorandum of Understanding and Access Agreement between the County and Siskiyou County Flood Control and Water Conservation District, Memorandum of Understanding and Access Agreement between the Flood Control and Water Conservation District and Reynolds Resorts - Lake Siskiyou LLC, and associated Deed Restriction for the Lake Siskiyou Roof Replacement and Cable Beach Parking Lot projects utilizing California State Parks and Recreation (Prop 68) grant funding, in the amount of \$193,000. Approved.

It was moved by Director Kobseff, seconded by Director Valenzuela and carried, following a roll call vote with Directors Criss, Kobseff, Valenzuela and Haupt voting YES, and Director Ogren ABSENT, to approve, and for the Chair be authorized to execute, the Deed Restriction and the two Memorandum of Understanding and Access Agreements.
