Pre-Bid Walk Through: On February 3, 2022 at 10:00 A.M., A pre-bid walk-through will take place at 311 Fourth Street, Yreka CA 96097 for all prospective bidders. This walk through is <u>NOT</u> mandatory.

Project Description: Abatement of Flooring. Removal and disposal of all carpet, flooring tiles and mastics. All local, state and federal laws will be followed.

General Information: General Services is seeking bids for the abatement of flooring. This will include the removal and disposal of all carpet, tiles and mastics. General Services is seeking two (2) different bid options. Please see Attachment "A" with all room numbers.

- Bid Option 2 Room 101 Approximately 360 sqft.
