4. Siskiyou County LAFCo Proposed Budget for Fiscal Year 2021-2022

Pursuant to California Government Code Section 56381, Siskiyou LAFCo will consider and adopt its proposed budget for fiscal year (FY) 2021-2022. Siskiyou LAFCo will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, Siskiyou LAFCo may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

The Local Agency Formation Commission (LAFCo) of Siskiyou County is pleased to announce the availability of the revised Municipal Services Review (MSR) reports for the Cities of Dorris, Dunsmuir, Etna, Fort Jones, Montague, Mount Shasta, Tulelake, Weed, and Yreka. Siskiyou County LAFCo invites public comment on the reports, analysis, and determinations. The MSR reports are an inventory of service capability for the Cities. It provides baseline information about existing conditions and issues concerning public services. Preparation of MSR reports are required by state law: The Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000. Among other purposes, the reports are a legal pre-requisite to updating the Spheres of Influence (SOI) for each city and special district.
