Notice of Public Hearing

Notice is Hereby Given that Siskiyou County Local Agency Formation Commission (LAFCo) will hold a Public Hearing on **Tuesday, April 13, 2021, at 2:00 p.m.** on the project described below. This Public Hearing is being noticed as a special meeting to allow Commissioners, Staff, and the public to participate in the meeting via teleconference, pursuant to <u>Governor's Executive Order N-29-20</u> dated March 17, 2020. Executive Order N-29-20 authorizes local legislative bodies to hold public meetings via teleconference and to make public meetings accessible telephonically or otherwise electronically to all members of the public.

The public may attend by Zoom/teleconference, but it is unknown at this time whether the public hearing will be held via Zoom/teleconference only. This decision will be made based upon COVID-19 infection rates as the meeting date approaches and will be set forth on the meeting agenda posted both online and physically the Friday before the meeting.

Siskiyou County LAFCo Proposed Budget for Fiscal Year 2021-2022

Pursuant to California Government Code Section 56381, Siskiyou County LAFCo will consider and adopt its proposed budget for fiscal year (FY) 2021-2022. It is anticipated that adoption of the proposed budget for FY 2021-2022 will be determined to be a government fiscal activity or funding mechanism which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines. Siskiyou LAFCo will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, Siskiyou County LAFCo may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

Siskiyou County LAFCo's proposed budget documents for FY 2021-2022 are on file with Siskiyou County LAFCo located within the Siskiyou County Community Development Department, 806 South

Main Street, Yreka, California, 96097, and are available for public review. A staff report and all attachments will be available for public review three working days prior to the meeting either at the Siskiyou County LAFCo office or online on Siskiyou County LAFCo's meeting page.

All items presented to Siskiyou County LAFCo during a public hearing, including but not limited to, letters, e-mails, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of Siskiyou County LAFCo. It is advised that the presenter bring 12 copies of anything presented to the Siskiyou LAFCo and that the presenter create copies in advance for their own records.

Any concerns or issues relating to the proposed budget must be raised during the public review period or at the public hearing. Public comments can be submitted via mail or hand delivery to Siskiyou County LAFCo, or by email to lafco@co.siskiyou.ca.us. Please include your name and physical address. Comments must be received by Siskiyou County LAFCo by 5:00 p.m. the day before the public hearing. If you challenge either the proposed project or the project's environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to Siskiyou County LAFCo prior to or at the public hearing.
