

Notice of Public Hearing

Notice is hereby given that the Siskiyou County Local Agency Formation Commission (Siskiyou County LAFCo) will hold a public hearing on **Tuesday, April 14, 2026, at 9:00 a.m.**, in the Siskiyou County Meeting Chambers, **311 Fourth Street, 2nd Floor, Yreka, California**, to consider the following:

Evans-Wilmarth Annexation (LAF-23-01)

The proposal is an owner-initiated annexation of approximately 3.20 acres of unincorporated territory from the County of Siskiyou to the City of Yreka, consisting of a portion of APN 014-430-120 to be merged with APN 062-202-150 along Murray Avenue. The annexation would result in a jurisdictional boundary change only; no development is proposed.

Environmental Review (CEQA)

The City of Yreka, as Lead Agency, determined the annexation to be categorically exempt from CEQA pursuant to CEQA Guidelines §15319 (Class 19) and filed a Notice of Exemption. LAFCo, as a Responsible Agency, will consider that determination when acting on the proposal.

Project documents, which include the project application, circulated CEQA documents and any other non-draft documents, are on file at the Planning Division of the Siskiyou County Community Development Department, 806 South Main Street, Yreka, California, 96097. A staff report and all attachments will be available for public review three working days prior to the meeting either at the Planning Division office or online on Siskiyou County LAFCo's meeting page:

All items presented to Siskiyou County LAFCo during a public hearing, including but not limited to, letters, e-mails, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Commission. It is advised that the presenter bring 12 copies of anything presented to the Commission and that the presenter create copies in advance for their own records.

All public records related to an open session item on the Agenda which are not exempt from disclosure pursuant to the California Public Records Act that are distributed to a majority of the legislative body will be available for public inspection at 806 South Main Street, Yreka, CA 96097, at the time that the public records are distributed or made available to a majority of the members of the legislative body.

Any concerns or issues relating to the application must be raised during the public review period or at the public hearing. Public comments can be submitted via mail or hand delivery to Siskiyou County LAFCo or by email to lafco@co.siskiyou.ca.us. Please include your name and physical address.

Comments must be received by 5:00 p.m. the day before the public hearing. If you challenge either the proposed project or the project's environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to Siskiyou County LAFCo prior to or at the public hearing.
