Notice is hereby given that the Siskiyou County Local Agency Formation Commission (Siskiyou County LAFCO) will hold a public hearing on **Tuesday, May 12, 2026, at 9:00 a.m.**, in the Siskiyou County Meeting Chambers, **311 Fourth Street, 2nd Floor, Yreka, California**, to consider the following:

Siskiyou County LAFCO Proposed Budget for Fiscal Year 2026/2027

Pursuant to California Government Code Section 56381, Siskiyou County LAFCO will consider and adopt the proposed budget for Fiscal Year (FY) 2026/2027.

Environmental Review (CEQA)

Adoption of the proposed budget for FY 2026/2027 is anticipated to be a government fiscal activity that does not involve any commitment to a specific project which may result in a potentially significant physical impact on the environment, and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to Section 15378(b)(4) of the CEQA Guidelines.

Siskiyou County LAFCO's proposed budget documents for FY 2026/2027 are on file at the Siskiyou County LAFCO office, located within the Planning Division of the Siskiyou County Community Development Department, 806 South Main Street, Yreka, California 96097, and are available for public review upon request. A staff report and all attachments will be available for public review at least three (3) working days prior to the LAFCO meeting at the Siskiyou County LAFCO office or online at the [meeting page](#).

All items presented to Siskiyou County LAFCO during a public hearing, including but not limited to, letters, emails, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Commission. It is advised that the presenter bring 12 copies of anything presented to the Commission and that the presenter create copies in advance for their own records.

All public records related to an open session item on the agenda that are not exempt from disclosure under the California Public Records Act and that are distributed to a majority of the Commission will be available for public inspection at 806 South Main Street, Yreka, CA 96097, at the time that the public records are distributed or made available to a majority of the members of the Commission.

Any concerns or issues relating to the application must be raised during the public review period or at the public hearing. Public comments can be submitted via mail or hand delivery to Siskiyou County LAFCO or by email to lafco@co.siskiyou.ca.us. Please include your name and physical address.

Comments must be received by 5:00 p.m. the day before the public hearing. If you challenge this item or its environmental determination in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to Siskiyou County LAFCO prior to or at the public hearing.
