

# Notice of Public Hearing

**Notice is Hereby Given** that the Siskiyou County Planning Commission will hold a Public Hearing on **Wednesday, October 15, 2025 at 9:00 a.m.**, or as soon thereafter as the matter may be heard, in the Siskiyou County Meeting Chambers, 311 Fourth Street, Second Floor, Yreka, California, on the project described below.

It is not known if the opportunity to attend remotely over the internet will be available at the time of this notice. Please review the Planning Commission's published agenda 72 hours before the meeting to see if remote attendance will be available.

## Crum Tentative Parcel Map (TPM-25-05)

**Project Location and Description:** The project site is located at 1509 Kidder Creek Road, Greenvew; APN: 024-230-290; Township 43N, Range 9W, Section 30, MDBM; 41.5504°, -122.9281°. The project is a proposed tentative parcel map to divide an existing 39.93-acre parcel into two parcels of 25.48 acres and 14.45 acres. Each of the two existing dwellings are proposed to be on a separate parcel. No new development is proposed as part of this project.

It is anticipated that the project will be determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Sections 15061(b)(3) and 15301 of CEQA Guidelines. A "categorical exemption" means an exemption from CEQA based on a finding that the class of projects does not have a significant effect on the environment. The Planning Commission will consider the appropriateness of said environmental recommendation based on the record of evidence before them. If substantial evidence has been presented demonstrating a more appropriate environmental determination than the one that has been recommended, the Planning Commission may require and/or approve an alternative environmental determination pursuant to the requirements of CEQA.

Project documents, which include the project application, circulated CEQA documents and any other non-draft documents, are on file at the Planning Division of the Siskiyou County Community Development Department, 806 South Main Street, Yreka, California, 96097, and are available for public review upon contacting the staff planner. A staff report and all attachments will be available for public review three working days prior to the Planning Commission meeting either at the Planning Division office or online on the Siskiyou County Planning Commission's: [meeting](#)

All items presented to the Planning Commission during a public hearing, including but not limited to, letters, e-mail, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Clerk of the Commission. It is advised that the presenter bring 12 copies of anything presented to the Commission and that the presenter create copies in advance for their own records.

All public records related to an open session item on the Agenda which are not exempt from disclosure pursuant to the California Public Records Act that are distributed to a majority of the legislative body will be available for public inspection at 806 S. Main Street, Yreka, CA 96097, at the time that the public records are distributed or made available to a majority of the members of the legislative body.

Any concerns or issues relating to the application must be raised during the public review period or at the public hearing. Public comments can be submitted via mail or hand delivery to the Planning Division (806 S. Main Street, Yreka, CA 96097) or email to [planning@co.siskiyou.ca.us](mailto:planning@co.siskiyou.ca.us). Please include your name and physical address. Comments must be received by the County by 5:00 p.m. the day before the public hearing. If you challenge either the proposed project or the project's environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to Planning prior to or at the public hearing.
